II. Clerk Report: Approve Minutes from July meeting

Chris Plankey explained the vestry did not meet in July but that a set of minutes was produced for July explaining this.

III. Old Business

Action Items from previous Meeting:

- 1. Nina and wardens to decide time and location for vestry retreat. Done.
- 2. Vestry members to sign up for VPOD slots for Aug. 2025 through Feb. 2026. Done, although 2 slots remain.
- 3. Vestry members are asked to suggest bookkeepers they recommend. Contact has been made with The Breezy Bookkeeper in Dalton. BIC used them and they are well-versed with churches, nonprofits, etc.

IV. New Business

a. Retreat Working Group Discussion

Our vestry retreat produced 3 working groups all focusing on one question: "How do we better serve the needs of the community around us?" Three specific areas emerged.

The first group focuses on how we utilize the parish house space, so that it better serves the community. That group has been reaching out to community organizations that serve the greater community and reported back their findings.

The second group's focus is on evangelism. Specifically on how to recruit/support the ministry already happening in our spaces at St. Stephen's. The goal is not to "fill the pews" but in bolstering/expanding current ministry. This group did not report back any specific update at this time. Members of this group may fold into one of the other groups.

The third group's focus is on thinking about St. Stephen's longer-term success. Are there things we should be thinking about and discussing now to put us in a stronger position for where we'll find ourselves in 2 years? 5 years? 10 years? Beyond? The group has met a few times and gave an update on their progress.

b. Solar Discussion

An update was given on the status of our solar project. Costs, engineering, contracts, fees, etc. We discussed whether the project aligns with our long-term goals. Ultimately, we agreed the timing is bad.

MOTION: "Does this body wish to pursue a solar installation at this time?" Made by John Garinther. Seconded by Chris Perry. 2 in favor. 6 not in favor. Abstained: Chris Plankey as a non-voting member. The motion does not pass.

V. Committee Reports

a. **Treasurer's Report** (Chris Perry)

The report explains:

- the group did not meet in June or July and offers a catch up report for a three month period
- on July 10th, Bill O'Neill, Assistant Treasurer, resigned due to ongoing health issues
- where we stand with our natural gas contract
- a summary of income and expenses through July

Chris would like to look at 5 year trends for natural gas. He aims to separate operating from non-operating/capital expenses in our budget.

No questions were asked of the treasurer's report.

b. **Property Committee** (Christopher Plankey)

The report contains updates on:

- our heating system upgrades
- our sanctuary sound system upgrades
- the safety inspections of our exterior staircases
- the balcony clean up and ceiling repair
- the sanctuary roof leak
- the solar roof load analysis plan
- the plan to repair the wall behind the crucifer station
- John's vacation schedule
- the acolyte room clean up

No questions were asked of the property report.

c. **Wardens' Report** (John Garinther, David Nevin)

No questions were asked about the wardens' report.

The report includes:

- 1. vestry housekeeping reminders, including sign ups for VPOD assignments and information about upcoming Safe Church training
- 2. a summary of recent and upcoming Parish events including the confirmation ceremony, Bishop visitation, and the vestry's meeting with the Bishop Fisher on Sept. 21st
- 3. Stewardship Team Update:

The Stewardship Team is currently meeting every 2-3 weeks. Susan LeBourdais is the Chairperson. The team is working toward the launch of a capital campaign to raise funds for specific projects:

- \$70K Dining Room/Foyer refresh (recover endowment draw)
- \$60K Boiler Condensate Tank and Boiler Digital Control System
- \$15K Steinway piano refurbishment
- \$5K Sanctuary sound system upgrade

The newly focused (and reduced) campaign goal is \$150K.

- 4. An update on our 2024 Financial Audit. Report artifacts were reviewed ahead of the meeting and the vestry voted to approve the report. See item IV. b. (above).
- 5. General Property Information The following are current or pending quotes that the Property Committee is pursuing:
 - Boiler BFT quote \$37k COMPLETE
 - Boiler Control System upgrade quote \$25k COMPLETE
 - Sanctuary Ceiling Fan installation quote
 - Cross Beam Load Analysis \$5,500 APPROVED
 - Ceiling Fan Material PROJECT CANCELLED
 - Ceiling Fan Installation PROJECT CANCELLED
 - Steinway Piano Back Action Overhaul (dampers) quote \$2K -PROJECT IN PROGRESS
 - Steinway Piano Keyframe Action quote \$11K PROJECT IN PROGRESS
 - Sound System Upgrade estimate \$5k QUOTED PENDING

d. **Rector's Report** (Nina+)

The report includes information on:

- 1. Nina's upcoming schedule and other liturgical events
- 2. the Bishop's visitation on Sept. 21st

- 3. Nina's vacation from September 23 through October 13th (returning to work on Sunday, Oct. 14th) and details on clergy coverage for those 3 Sundays

- 6. an update on Nina'a sabbatical plans
